## Statement on Marriage and Sexuality

We believe that the term “marriage” has only one meaning and that is marriage sanctioned by God which joins one man by birth and one woman by birth in a single, exclusive union, as delineated in Scripture. We believe that God intends sexual intimacy to only occur between a man and a woman who are married to each other. We believe that God has commanded that no intimate sexual activity be engaged in outside of a marriage between a man and a woman.

We consider all marriage ceremonies to be worship services. Due to our biblical conviction and denominational precepts, a pastor (or any other qualified official or organizational representative) will not be permitted to perform a transgender or same-sex “marriage” on the property or within facilities under Pillar Ministries control.

We believe that any form of sexual immorality, as stated in the Bible, is sinful and offensive to God.

We believe that in order to preserve the function and integrity of the church as the local Body of Christ, and to provide a biblical role model to the church members and the community, it is imperative that all persons employed by the organization in a capacity, or who serve as volunteers in a ministry capacity, should abide by and agree to this Statement on Marriage and Sexuality and conduct themselves accordingly.

### **The Facts:**

1. Jesus Christ ordered Christians to be celibate (Matthew 19.)
2. Paul ordered men not to have sex with women, and to stay unmarried as was he (1 Cor. 7.)
